## NOTES TO THE DONOR

- i) If you pay tax in the UK, signing the Gift Aid Declaration will allow Denstone College, as a charity, to reclaim income tax (currently 28p for every £1 you give) upon the gift that you are making to The Denstone Foundation. It can also apply to any future gifts to Denstone that you may make. There is, however, no future obligation implied.
- ii) If you are a higher-rate tax payer, you will yourself be able to claim higher rate tax relief on your Self Assessment tax return. This is the difference between the basic rate and higher rate of tax on your gift and reduces the cost to you of making the gift.
- iii) If you have decided to make a **single gift** please send the completed Gift Aid Declaration together with your cheque made payable to **The Denstone Foundation**.
- iv) You may wish to consider spreading your gift over a number of years. If you do decide to, please complete and return to the Development Office the Standing Order form below, in addition to the signed Gift Aid Declaration.
- v) Please remember to notify us if in the future you no longer pay an amount of income tax and/or capital gains tax equal to the tax Denstone College will reclaim on your donations.
- vi) All **donations of shares** to a charity will receive tax relief of 100% of their market value. It is the donor, and not the recipient, who will achieve the tax savings both on capital gains and income tax. If you would like more information on gifts of shares, please contact the Development Office.
- vii) **Residents of the USA** should contact the Development Office for more information about how contributions can be made in a tax efficient way.
